Administrative Business and Announcements

- California Sea Grant State Fellow June Shrestha oriented Council members and attendees with instructions regarding webinar sign-in, audio and video set-up, and the protocol for effective participation in the virtual meeting.
- Chair Kristen Hislop called the meeting to order, provided opening remarks, and described the purpose and composition of the Sanctuary Advisory Council and its bi-monthly meetings.
- Deputy Superintendent for Programs Mike Murray confirmed online attendance, counting the presence of 25 Council members representing 16 out of 21 voting seats (Appendix A). In addition to Council members, ten members of the public and eight sanctuary staff attended the webinar.
- Chair Hislop announced two Sanctuary Advisory Council roster changes: Stephen (Steve) Duboyce now holds the Department of Defense alternate seat – following the retirement of former alternate Greg Sanders – and Lisa Wooninck now holds the Monterey Bay National Marine Sanctuary's primary member seat.

November 19, 2021, Draft Key Outcomes

- The Council approved the draft key outcomes from the November 19, 2021, Sanctuary Advisory Council meeting. Phyllis Grifman (Research seat) offered a motion to adopt the notes, which Stuart Kasdin (Public-At-Large seat) seconded. Chair Hislop led a voice vote. There were no oppositions or abstentions to the vote.

Council Member Announcements

• Council members shared a variety of announcements about recent events from their respective groups, organizations, and agencies.

- Chief Warrant Officer Paul Ricketson provided a brief presentation on behalf of Commander Justin Noggle with the US Coast Guard.
 - Presentation highlights included marine environmental protection statistics in San Luis Obispo, Santa Barbara, and Ventura Counties; a case summary of a sheen near Platform Holly in December 2021; and a series of recent and upcoming living marine resources activities, including a qualification course at the Pacific Regional Fisheries Training Center, the US Coast Guard's involvement in the management and enforcement of the California marine protected area network, and a December 2021 report of illegal recreational fishing activity in the Anacapa Island Federal Marine Reserve.
- Written council member announcements submitted prior to the meeting can be found in Appendix B.

Sanctuary Superintendent's Report

- Sanctuary Superintendent Chris Mobley began by updating Council members on current coronavirus conditions, outlooks, and challenges at the Channel Islands National Marine Sanctuary (CINMS) and other sites. He went on to share 2022 budget possibilities, priorities, and expectations.
- Mobley announced the upcoming retirement of long-time CINMS Education Coordinator Laura Francis, arrival of new California Sea Grant State Fellow Samantha (Sam) Cook, and departure of current Fellow June Shrestha.
- Mobley informed Council members of a newly released <u>#SaveSpectacular social media</u> <u>toolkit</u> in celebration of the 50th anniversary of the Office of National Marine Sanctuaries (ONMS), and encouraged them to bring attention to the sanctuary system through their organizations' social media channels.
- Mobley provided an update on the scoping process for the proposed Chumash Heritage National Marine Sanctuary. Three well-attended online public comment meetings were held between December 2021 and January 2022. As of January 20, 2022, 569 public comments were received on the proposal, and Tribal engagement is ongoing.
- Mobley shared a message from ONMS headquarters to Sanctuary Advisory Councils nationwide in honor of <u>50 Years of Ocean and Coastal Conservation</u> which praised them for their role in advancing marine conservation efforts.
- Mobley concluded the superintendent's report by explaining how sanctuary divers surveyed kelp rafts and collected samples to better understand kelp nutrient cycling, and how the sanctuary deployed the R/V *Shearwater* to support a testing mission for aerial detection of marine debris, kelp beds, and oil.

CINMS Draft Management Plan: Council Commenting

• Murray provided Council members with an update on the management plan revision process, including recent and upcoming opportunities and outreach for public comment

on the draft management plan (DMP) and draft environmental assessment (DEA). Murray also described new and existing initiatives contained within the DMP.

Murray invited each Council member in attendance – by seat – to contribute their comments on the DMP and DEA, beyond those that CINMS staff had received prior to the meeting. The Council member commenting period concluded with over ten pages of comments across DMP Action Plans and the DEA. Michael Cohen (Tourism seat) offered a motion to adopt and submit the <u>collection of comments to NOAA/CINMS via</u>
Regulations.gov, which Cliff Rodrigues (Education seat) seconded. Chair Hislop led a voice vote. The vote result was 12-yes and 0-no, with two seats abstaining (California Department of Fish and Wildlife, and Department of Defense). A decision was made to circulate the comment document and cover letter for Council member review prior to submission to the official comment record.

Public Comment

• No public comments were provided.

Council Annual Planning

- Mike Murray shared a list of potential topics for consideration in 2022 Sanctuary Advisory Council meeting agendas. Murray reminded Council members of the process through which the list was drafted, including a review of select strategies and activities found within the DMP as well as via Council member suggestions.
 - June Shrestha informed Council members that they would be ranking the list of meeting topics so CINMS staff and the Executive Committee could gain a sense of which items are of particular interest to the Sanctuary Advisory Council. Due to time constraints, Shrestha committed to emailing the poll to Council members for completion by January 23, 2022.
- Murray introduced Shrestha's 2021 California Sea Grant State Fellowship reflection and commented on this being her last Sanctuary Advisory Council meeting with CINMS. Shrestha shared highlights of her fellowship with CINMS, what it meant to and taught her, and where she is headed next.

The California Department of Fish and Wildlife (CDFW) announces multiple changes to recreational rockfish sub-bag limits which are expected to take effect Jan. 6, 2022. The emergency regulations were adopted by the California Fish and Game Commission in mid-December to align with federal regulations for these species. Changes to the sub-bag limits within the 10-fish daily Rockfish, Cabezon, Greenling (RCG) complex bag and possession limit include:

- A decrease to the statewide sub-bag limit for vermilion rockfish (Sebastes miniatus) from five fish to four fish
- A new statewide sub-bag limit for quillback rockfish (S. maliger) of one fish
- A new statewide sub-bag limit for copper rockfish (S. caurinus) of one fish

The RCG complex has a daily 10-fish bag and possession aggregate limit, meaning that each angler's catch can be composed of any combination of rockfish, cabezon or greenling, as long as total catch remains at or below 10 fish. Sub-bag limits within the RCG bag limit are implemented when harvest guidelines cannot accommodate the 10-fish bag limit being composed of a single species.

"New stock assessments conducted in 2021 for quillback and copper rockfish suggest severe population declines for these two species. Also, unsustainably high catches of vermilion rockfish have occurred each year since 2015," said CDFW Environmental Program Manager Marci Yaremko. "For these reasons, new federal regulations were needed to implement reduced sport bag limits for these three species in 2022."



Name: Kim Selkoe Seat: Commercial Fishing Announcement: Update on the Maritime Collective and fisheries advocacy

Maritime Collective: The Commercial Fishermen of Santa Barbara and its partner, the City of Santa Barbara has been awarded a \$100,000 grant from the U.S.D.A. to fund preparation of a feasibility study for the creation of a Maritime Collective, an economic development and infrastructure initiative reliant on the sustainable fisheries of the Santa Barbara Channel. The Collective is a multifaceted facility and seafood hub that will:

- satisfy our seafood industry's requirements for harbor-adjacent space for fishing gear and boats, live and cold storage, and seafood processing,
- provide workshop/office space to house emerging 'Blue Economy' entrepreneurs, and
- serve as a nexus for educating students and the public about ocean health, sustainable resource use and emerging ocean technologies.

There is currently no other hub similar to what the Maritime Collective will be for seafood storage, processing, and distribution, which could serve the needs of fisheries operating out of the Santa Barbara Channel, one the most productive regions for fishing on the west coast. A similar model does exist in the Icelandic Ocean Cluster (IOC), which has been replicated in a network of Ocean Clusters all over the word, including in Portland, ME; Seattle, WA; New Bedford, CT, Alaska, Norway, and other fishing communities.

The study will conduct stakeholder workshops that will seek engagement and collaboration with fishers, buyers, seafood processors, restaurants, and other businesses in the seafood supply chain. If interested in participating, please contact Kim Selkoe: kim@cfsb.info

State and Federal Initiatives: The Commercial Fishermen of Santa Barbra are confronting multiple state and federal initiatives that will further restrict or eliminate fishing opportunities along the entire California Coast: Offshore Wind Energy Areas, Chumash Heritage National Marine Sanctuary, Aquaculture Opportunity Areas, Pathways to 30x30.

Presently CFSB is working with fishing organizations from Crescent City to San Diego to develop a framework and principles that would equitably mitigate the offshore wind industry's inevitable disruption and displacement of fisheries. The current focus of these efforts are Fishing Community Benefit Agreements and the entities and organizational necessary to administer them
