Re: Letter of Commitment for the Climate Pollution Reduction Grant Opportunity "Reducing Ocean-Going Vessel Speeds - Protecting Blue Whales and Blue Skies (BWBS)"

Dear Mr. Harris:

On behalf of the Channel Islands National Marine Sanctuary Advisory Council (Sanctuary Advisory Council) I am submitting this letter of commitment in respect to the **Ocean-Going Vessel Speeds - Protecting Blue Whales and Blue Skies (BWBS)** implementation grant application for the Climate Pollution Reduction Grant (CPRG) as part of the Inflation Reduction Act. We strongly support the continuation and expansion of this program through the CPRG implementation grant application.

The CINMS Advisory Council's 21-member body brings together community members and representatives from government agencies to advise the CINMS and the National Oceanic and Atmospheric Administration National Marine Sanctuaries Program¹.

The BWBS program engages and enrolls large global shipping lines to motivate them to reduce speeds to 10 knots in key areas off the California coast to reduce air pollutant emissions, underwater noise, and the risk of fatal ship strikes to endangered and threatened whales. Since 2014, the program has achieved more than 150,000 metric tons of regional greenhouse gas emission reductions, over 4,400 tons of harmful oxides of nitrogen (NOx) emission reductions, and an estimated 50+% percent decreased risk of fatal whale strikes in the vessel speed reduction zones off California.

The Sanctuary Advisory Council has actively participated in vessel speed reduction (VSR) efforts since 2007, and served as the public policy forum for the genesis of the Protecting Blue Whales and Blue Skies VSR program. In addition, in 2015 the Sanctuary Advisory Council convened a Marine Shipping Working Group subcommittee composed of representatives of the Sanctuary Advisory Council, shipping interests,

environmental groups, whale researchers, port specialists, and technical experts to explore methods to reduce the incidence of fatal ship strikes on whale populations in the Santa Barbara Channel. The continuation of BWBS Voluntary Vessel Speed Reduction program was one of the recommendations of that subcommittee deemed most vital and with the highest prospects for success². The CINMS

Advisory Council sees the value Protecting Blue Whales and Blue Skies has had since 2014 and the monumental positive impacts it has had on our climate and wildlife, including protected and endangered large whale species.

The BWBS program is readily expandable to other parts of the California coastal waters given the resources and local partners. A statewide vessel speed reduction program could cut greenhouse gas emissions significantly as part of a comprehensive effort to reduce emissions from ocean-going vessels. CPRG funding will allow the BWBS program to expand statewide and provide funds to increase the positive public relations campaign and the health of whales and coastal communities and develop partnerships with interested state and local agencies outside of California.

The Sanctuary Advisory Council is pleased to support the Ocean-Going Vessel Speeds - Protecting Blue Whales and Blue Skies (BWBS) application and requests federal assistance to continue and expand the successful operation of this program and further reduce harmful air pollutants and impacts to wildlife along the California coast.
